You are also not permitted to drive on any part of the racecourse at any time. No Exceptions. Tampering with any course markings or signage for any reason WILL NOT be tolerated and will result in immediate removal from the event.

RELEASE OF LIABILITY

For participation in the **Offroad Show & Camp** organized by Strategic Racing Designs, LLC ("SRD"), of 1352 N. Melrose Drive Suite A, Vista, California, 92083 and/or use of the property, facilities and services of SRD, I, agree for myself and (if applicable) for the members of my family, to the following:

1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by SRD, or the employees, representatives or agents of SRD.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge SRD for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of SRD, whether caused by the fault of myself, my family, SRD or other third parties.
3. I irrevocably grant SRD the unconditional and perpetual right to copy, reproduce, encode, store, transmit, publish, post, broadcast, display, publicly perform, adapt, exhibit and/or otherwise use or reuse (without limitation as to when or to the number of times), my member name, address, image, voice, likeness, statements, and biographical material in any media now known or hereafter developed throughout the world for any purpose, without limitation, and without additional review, compensation, notice to, or approval from me or any other party.
4. I agree to indemnify and defend SRD against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may arise from my or my family's use of or presence upon the facilities of SRD.
5. I agree to pay for all damages to the facilities of SRD caused by my or my family's negligent, reckless, or willful actions.
6. Any legal or equitable claim that may arise from participation in the above shall be resolved under California law.
7. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that SRD has offered to refund any fees I have paid to use its facilities if I choose not to sign this Agreement.
8. This Agreement and each of its terms are the product of an arms' length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity. Accordingly, the Parties specifically reject the application of Cal. Civ. Code 1654 to this Agreement, as well as any other statute or common law principals of similar effect.
