## RELEASE OF LIABILITY

- 3. I irrevocably grant SRD the unconditional and perpetual right to copy, reproduce, encode, store, transmit, publish, post, broadcast, display, publicly perform, adapt, exhibit and/or otherwise use or reuse (without limitation as to when or to the number of times), my member name, address, image, voice, likeness, statements, and biographical material in any media now known or hereafter developed throughout the world for any purpose, without limitation, and without additional review, compensation, notice to, or approval from me or any other party.

Accordingly, the Parties specifically reject the application of Cal. Civ. Code 1654 to this Agreement, as well as any other statute or common law principals of similar effect.
